Increasing greenhouse effect is part of the cycle of climate change

<u>Whereas</u> climate change is coming fast — intense heat and drought in the summer, all-time record cold in the winter for over twelve years, floods, hurricanes, tornadoes, earthquakes, clouds and snow increase, and shorter growing seasons in the middle and upper latitudes, and

Whereas the United States may have no surplus grain available two years from now if the drought and freezing continue as severe as they have been recently, and

whereas climate stabilization includes employment on soil, forest, conservation and alternative energy work to reduce atmospheric carbon dioxide; and a central organizing tool to carry out such job programs is the CO/2 Budget (A CO/2 Budget is a 12-month jobs, food and environment working plan for a region. This is in line with national and international movements for climate stabilization. Hungary is the first country to start on a CO/2 Budget and so announced in Hamburg, Federal Republic of Germany, at the "World Congress on Climate and Development," November 7-10, 1988),

Therefore be it resolved that the California Democratic Party, at its State Convention February 10-12, 1989, hereby resolves to request (1) the Governor of California, (2) county Boards of Supervisors, and (3) city governing bodies, to develop a CO/2 Budget, showing increases in atmospheric carbon dioxide and those activities (soil, forest and energy) that reduce CO/2, and

Be it further resolved that the California Democratic Party Chair shall work with the Environment Caucus and other Party members as he considers appropriate in carrying out this action.

Approved by the Environmental Caucus at its meeting Friday, February 10, 1989, and sent to the Resolutions Committee and the State Democratic Party Convention for approval and action.


